Thank you for your email of 6 March on behalf of your constituent, Mr Naji Hamid, about the death sentences confirmed by Iran's Supreme Court for Muhhamad Ali Ammouri, Hashim Sha'abani, Hadi Rashdi, Sayed Jabir Albushawka and Sayed Mukhtar Albushawka.

I remain deeply concerned about these five individuals from the Ahwazi Arab minority and their appalling treatment. The death sentences passed on these men without due process constitute a clear violation of their human rights. The nature of their arrest and treatment in jail, including reports of torture, is shocking.

You may be aware that earlier this month the EU designated the judge (Seyed Mohammad Bagher Ahwaz Moussavi) who originally handed down the sentences under EU Iran human rights sanctions.

Our officials in the Iran Department have also been in contact with the UN Special Rapporteur for Human Rights in Iran concerning your constituent's correspondence. He shares our urgent concerns about the plight of the five individuals.
